

NREC COVID-19 Comments	 The committee agreed that this application represented an extensive health care survey which presented very few issues The committee noted that participants' use of a mobile phone during an evaluation of health literacy may inherently represent a potential bias
NREC COVID-19 Decision	Provisional approval
Associated Conditions	 The committee requests further information on how capacity to consent will be assessed during the phone interview (section 4.2.1). The committee requests that in the Participant Information Leaflet, under the risks and benefits section, participants should be encouraged to contact their General Practitioner prior and in addition to directing them to appropriate helplines.

3.	The committee notes that the gender options are currently
	only 'male and female' in the questionnaire and requests these
	options be broadened as per best practice for inclusion.

NREC COVID-19 Comments	The committee noted that this application represents a multisite survey of junior medical doctors interning in 2019 and 2020
NREC COVID-19 Decision	Provisional approval
Associated Conditions	 The committee notes that the start date on the application form is May 2020 (section 2.3) and requests clarity on whether study has already commenced or not. The committee notes mention of 'validated inventories", which address stress and resilience (section 2.5); however, no further detail is provided on these. The committee requests that further information is provided on the 'validated inventories' used in the questionnaire. The committee requests clarity on what the survey wants to achieve and justification of how this is reflected in the questions, and what is being measured in each of the sections. The committee requests more information on the purpose of the 6-month follow-up and whether the same methodology will be used. The committee requests confirmation of the survey tool to be used. The committee requests inclusion of an introduction / preamble to the survey with information on the purpose, outcome, data protection and consent. The committee requests more information on the recruitment of participants: Who in the organisation will send out emails and requests? How are the participants for the qualitative element to be selected and how will confidentiality be maintained with the small sample size? What methodology will be used to gain access to the 2019-2020 cohort of interns who have now finished?

	sought in the questionnaire and clearly addressed in the
	Participant Information Sheet.
9.	The committee requests that information on how data will be
	collected and retained is clearly set out in the research Participant
	Information Sheet.
10.	The committee notes that the applicant has stated that GDPR is
	not applicable to this study (section 9.1.1). The committee
	requests more information on how the survey will be
	administered, who will have access to the participants' email
	addresses, how qualitative data will be anonymised and stored,
	and who will have access to this data.
11.	The committee requests that the applicant consult their
	institutional DPO for data protection advice before the study
	commences.

	2. The committee notes there is no power calculation provided and suggests the study will be unlikely to recruit the number

3.	required to derive information on burnout rates in different staff groups; the committee requests justification of same. Regarding the participant information leaflet (PIL) ('invite'), the
	committee requests the logos of the two organisations involved are included, in addition to the name and contact details of the Principal Investigator.
4.	The committee requires confirmation that the Principal Investigator will endeavour to provide the PIL to all potential participants in advance of verbal approach in the ED.
5.	The committee is of the view that the cartoon is inappropriate on the 'invite' given the topic, and requests its removal.
6.	The committee suggests the timeframe is tight for data collection by one individual in a very busy environment across two geographically separate sites, and requests comment on this challenge.
7.	The committee asserts for the record that the data controller for the study is the Principal Investigator and not the medical student gathering the data.

NREC COVID-19 Comments	 The committee noted that this application represents an online pseudonymised study of mental health in over 500 healthcare workers in 5 Dublin Adult hospitals.
NREC COVID-19 Decision	Provisional approval
Associated Conditions Associated Conditions	 The committee notes that Qualtrix is a commonly used tool, however it requires justification as to the security that it can afford the participants' data including plans to immediately deidentify the data (including URLS, cookies) when received. The committee is of the view that the indicated timeframe of 10 minutes to complete the online form is unrealistic and that 30 minutes is a more appropriate estimate; please amend accordingly. The committee asserts that the survey methodology as proposed will inherently have a healthy work bias, and requests comment on how the Principal Investigator proposes to manage this. The committee observes that the study will be run at three time-points, however it is unclear if the intention is for the same group from time-point 1 to be surveyed again at the second and third time-points, or if three separate recruitments take place. Furthermore, the committee is unclear if the population being asked to participate are those who will be employed by the same hospital for all three time periods, which may exclude junior doctors on rotation. Further to above, the committee is unclear if the intention of the study is to generate longitudinal data. Depending on confirmation of same by the Principal Investigator, the committee requires that one of two alternative approaches be pursued. If the intention is to conduct a longitudinal study, the committee requests that true appropriate identifiers are collected (and not use the proposed code) to enable accurate data and meaningful observations to be derived. Alternatively, if the intention is to gather data at three time-points over three independent exercises, then there is no requirement to attempt to link the data and therefore the proposed code should not be used

	study to inform future planning to protect those most
	vulnerable during infectious disease pandemics.
NREC COVID-19 Decision	Provisional approval
Associated Conditions	1. The committee notes there is agreement between the clinical
	leads at the sites, however it queries whether formal agreements
	are in place between the respective hospitals.
	2. Recognising that the participant list will be generated from the
	microbiology laboratory records, the committee requests
	clarification on the agreement from the laboratories to do this; for
	example, are the clinical leads from these laboratories?
	3. The committee advises that the use of postal addresses to
	generate a person's socioeconomic/deprivation status is not
	necessarily accurate and therefore this should be recognised in any
	analyses. It also requests some explanation as to how this link will
	be made on entering the data without the address going into the
	database first so that this link can be made afterwards. It seems
	unlikely that the researchers will be able to do this immediately
	while gathering this data – as intimated in the application. If it is to
	be done later assurance needs to be given that the data will be kept
	securely until this is done and that the link will be made ASAP and
	addresses deleted.
	4. The committee requests amendment to the inclusion criteria to
	include those who are in fact 18 years of age (ie, ≥18 years)
