1. Conflict of Interest

4. CEO's Report

PhD Stipend

The CEO informed the Board that the matter of the current level of the PhD stipend had been under discussion amongst the research funding agencies and that concern had been expressed that the stiped was not adequate in light of increasing rents, the cost-of-living crisis, and inflation. She said that the Department of Further and Higher Education, Research and Science, may wish to coordinate a multi-agency, national approach to the issue and seek funding through the estimates process.

It was agreed that it would be appropriate for the HRB to make a 'one-off' payment to assist PhD students until such time as a national solution is agreed.

5. Outline of Agenda for Board Strategy Day

The Board considered a draft agenda fort its annual Strategy Day on Friday 11 November 2023. It was agreed that the discussion on the matter of the Implementation of the HSE's Action Plan for Health Research (2019–2029) and implications for the HRB's strategy should include a briefing on the outcome of a preliminary meeting between representatives of the Board of the HSE and the Board of the HRB scheduled to take place on 29th September 2022.

6. Health Research Careers Framework

Dr Montesanti presented an overview of the HRB's health research careers framework. The benefits of completing an evaluation of the HRB's investment in research careers was discussed and it was agreed that meetings with the Universities was an appropriate point at which to start the process to address the many institutional barriers to career progression.

It was agreed that the Board should consider the matter of research careers on a regular basis.

7. Programme of Work for the Board and Listed Conflicts of Interest

The Board noted the programme of work for the remainder of 2022 and the listed conflicts of interest.

8. HRB Service Plan 2022 – Status Report as at 30 June 2022

The Board noted the report on status of HRB's Service Plan for 2022 as at 30 June 2022 and approved its submission to the Department of Health's Research Services and Policy Unit as the progress report on the annual Performance Delivery Agreement

9. Approval to issue calls

a) Post-Doctoral Fellowships 2023

The Board approved the simultaneous announcement of a call for two HRB Post-doctoral Fellowship schemes to fund in the region of 16 fellows. The Schemes approved were 'Applying Research into Policy & Practice' (ARPP) and 'Clinician Scientist Fellowships' (CSF).

b) Secondary Data Analysis Projects (SDAP) 2023

The Board approved the issuing of a call for the Secondary Data Analysis Projects (SDAP) to support 8-10 awards between 2023 and 2024.

10. Other Research Funding Matters

HRB Policy for Change of Principal Investigator

The Board noted the HRB Policy for change of Principal Investigator and a report on the outcome of implementing this policy in response to a recent request.

11. Evidence Reviews

Impact of community water fluoridation on systemic health excluding oral health.

The Board reviewed the process to prepare the evidence review entitled the Impact of community water fluoridation on systemic health excluding oral health, including the peer review comments and authors' responses, and agreed that it should go forward for publication.

12. Corporate reporting

HRB Management Accounts to 31 August 2022

The Board noted the Management Accounts for the eight months ended 31 August 2022 and the revised forecast of year end outturn.

Procurement Activity Report

The Board approved the award of a 36-month contract to Allen Creative for the provision of design and print services for the HRB with an option to extend by twelve months. The maximum value of this contract is €320,000 excluding VAT.
