



Figure 3 Primary diagnostic category by age group (11,911 records), NPSDD 2016








Figure 6 Participation restriction (8,092 records), NPSDD 2016





Figure 7 WHODAS 2.0 - World Health Organization Disability Assessment Schedule (8,092 records), NPSDD 2016
